



The Solo Performance Commissioning Project UK 2009

Led by choreographer Deborah Hay
26th August – 4th Sep 2009, Findhorn, Scotland

Commission fee £980 (inc. one meal per day)

Travel to and from Findhorn and accommodation is additional and organised by you.

This project is an experience directed at experienced professional performers. There is likely to be high demand for places - so early booking is advised!

Receipt of £100 deposit, will reserve you a place on the SPCP 2009, whilst you do your fundraising. To ensure your place on the project, you must pay the remaining amount at a date no later **than 30th April 2009**. If full, a waiting list will hold the names of those who have registered and paid their deposit, any spaces then released on 30th April will be passed on to those on the waiting list.

Whilst the commission fee must not come from your personal funds (see initial info) the deposit can be your own money. The full payment must come with clear indication/evidence of source(s) and appropriate acknowledgements.

Both the deposit and the fee should be paid in pounds sterling, so exchange rates and commission should be checked at the point and country of payment.
